**Declaring Single Calculated and Responsive Bid (SCRB); and,
Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **25 to 01 November 2023**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2023-10-0587 EPA / I.B. No. 2023-020 EPA** to wit:

WHEREAS, in response to the above advertisement, **six (6) prospective bidder/s**, namely: (1) **State Alliance Enterprises, Inc.**, (2) **Japan Radio Co., Ltd.**, (3) **West Point Engineering Supplies, Inc.**, (4) **Superserve Corporation**, (5) **Northwing Communications** and (6) **Constructicons, Inc.** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **13 November 2023**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid Conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2023-020-01** dated 31 October 2023, **Addendum No. 2023-020-02** dated 16 November 2023 and **Addendum No. 2023-020-03** dated 22 November 2023 are herein made part of this Resolution as **Annex "A"**, **Annex "B"** and **Annex "C"** respectively;

WHEREAS, on **18 December 2023**, the amended schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **State Alliance Enterprises, Inc.**, timely submitted its bid tender for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "Read", is as follows:
