



PAGASA Bids and Awards Committee Resolution (BAC)

Resolution No. 2024-001

**Resolution Declaring Single Rated and Responsive Bid (SRRB); and
 Recommending Award and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, posted the Notice to Bidders on 24 October 2023 in the MGEPS, PAGASA Website and PAGASA Bulletin Boards, notifying the public of its resort to alternative method of procurement through *Negotiated Procurement after Two Failed Biddings*, pursuant to Section V (D.3 (a.1) & (b.iv), Annex "H" of the Revised IRR of RA9184, the procurement of Consultancy Services for **GAP Assessment Study for Multi-Hazard Impact-Based Forecasting and Early Warning System for the Philippines**, with corresponding budget in the amount of **Four Million Five Hundred Thousand Pesos (Php4,500,000.00) Only**, under **Purchase Request No. 2023-07-0448**, inclusive of all applicable fees and taxes;

WHEREAS, the procurement of the said services has been undertaken through negotiated procurement – two failed biddings using Quality Based Evaluation/Selection (QBE) procedure with 70% minimum score to be shortlisted;

WHEREAS, on 13 November 2023, the BAC issued a Notice of Eligibility and Shortlisting to **CAPS & PARTNERS, INC.**, informing them that they passed the minimum score of 70%, as a requirement for shortlisting, and passed the eligibility check;

WHEREAS, pursuant to the provisions of the revised IRR of RA9184 for Consulting Services using a Quality-Based Evaluation Procedure, the P-BAC invited CAPS & PARTNERS, INC. for the opening of the technical and financial proposal on 29 November 2023;

WHEREAS, on 05 December 2023, the report on the detailed evaluation of bids conducted by the TWG and the End-user showed that CAPS & PARTNERS, INC. met the minimum requirements for the Financial Proposal with a submitted bid amount of **Four Million Four Hundred Seventy-Six Thousand Two Hundred Sixty-Eight Pesos & 16/100** inclusive of applicable taxes;

WHEREAS, the P-BAC declared CAPS & PARTNERS, INC. as the bidder with the **Single Rated Bid (SRB)**, and instructed the end-user to proceed with the negotiations of said bidder in accordance with Section 32.2.5 and Section 34;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by CAPS & PARTNERS, INC., the PAGASA-BAC determined that CAPS & PARTNERS INC. has complied accordingly on all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that **CAPS & PARTNERS INC.** be declared as the **Single Rated and Responsive Bidder (SRRB)** for the Project

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the PAGASA Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, CAPS & PARTNERS, INC.** as the bidder with the Single Rated and Responsive Bid (SRRB) for the project;
- b) to **RECOMMEND**, the award of the contract for **Consultancy Services for GAP Assessment Study for Multi-Hazard Impact-Based Forecasting and Early Warning System for the Philippines – NP** with a total contract price of **Four**
