**Declaring Single Calculated and Responsive Bid (SCRB); and,
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **22 to 29 Jan 2024**, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2023-12-0706 EPA / I.B. No. 2024-02** to wit:

WHEREAS, in response to the above advertisement, only one (1)) prospective bidder namely: (1) **Manila Allied Management Services Cooperative** expressed its intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **30 January 2024**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-02 01** dated 02 February 2024 and **Addendum No. 2024-02 02** dated 07 February 2024 are herein made part of this Resolution as **Annex "A" and Annex "B"** respectively;

WHEREAS, on **13 February 2024**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Manila Allied Management Services Cooperative** timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "**Read**", is as follows:
