Resolution No. 2024-018

**Declaring Lowest Calculated and Responsive Bid (LCRB); and,
Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **02 to 09 April 2024**, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-02-0134 / I.B. No. 2024-05** to wit:

WHEREAS, in response to the above advertisement, **two (2) prospective bidder/s** namely: (1) **A.G. Datacom Phils., Inc.**; and (2) **Accent Micro Technologies, Inc.** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **11 April 2024**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-05 01** dated 05 April 2024; **Addendum No. 2024-05 02** dated 15 April 2024; and **Addendum No. 2024-05 03** dated 22 April 2024 are herein made part of this Resolution as **Annex “A”**, **Annex “B”** and **Annex “C”** respectively;

WHEREAS, on **25 April 2024**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **three (3) prospective bidders** namely: (1) **Accent Micro Technologies, Inc.**; (2) **AG Datacom Phils., Inc.** and (3) **Tekzone Computer Sales and Services Inc.** timely submitted their bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the bidder’s financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as **“Read”**, is as follows:

WHEREAS, upon careful examination, validation, and verification of the three (3) bidder's tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that **A.G. Datacom Phils., Inc.** has complied accordingly with all the criteria for post-qualification and was responsive to all requirements and conditions specified in the Bidding Documents. Hence, it was moved and duly seconded that **A.G. Datacom Phils., Inc.** be declared as the **Lowest Calculated and Responsive Bidder (LCRB)** for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, A.G. Datacom Phils., Inc.** as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Project entitled, *"Supply, Delivery, Installation, Testing and Commissioning of Radar Mosaic Storage Server"*;
- b) to **RECOMMEND**, the award of the contract to **A.G. Datacom Phils., Inc.** in the actual bid amount of **One Million One Hundred Fifty-One Thousand Seven Hundred Eighteen Pesos (Php1,151,718.00)** only for the implementation of the Project; and
- c) to **RECOMMEND** finally, the **APPROVAL** of the foregoing findings and recommendations.
