



PAGASA BIDS AND AWARDS COMMITTEE (PBAC)

**Resolution No. 2024-028**

**Declaring 1<sup>st</sup> Failure of Bidding; and Recommending Approval**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **30 April to 07 May 2024**, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-02-0125 / IB No. 2024-15** to wit:

**WHEREAS**, in response to the above advertisement, **five (2) prospective bidder/s** namely: (1) **A.G. Datacom Phils., Inc.**; (2) **Tekzone Computer Sales and Services Inc.**; (3) **HPC Technologies Inc.**; (4) **Infobahn Communications Inc.**; and (5) **Pinnacle Technologies, Inc.** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **14 May 2024**;

**WHEREAS**, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2024-15 01** dated 15 May 2024; and **Addendum No. 2024-15 02** dated 17 May 2024; are herein made part of this Resolution as Annex **"A"**, and Annex **"B"** respectively;

**WHEREAS**, on **28 May 2024**, the scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **only, Tekzone Computer Sales and Services Inc.** timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

**WHEREAS**, in the subsequent opening of Envelope No. II (Financial Component), the bidder's financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as **"Read"**, is as follows:

**WHEREAS**, on **06 June 2024**, the report on the detailed evaluation of bids conducted by the TWG resulted that Tekzone Computer Sales and Services, Inc. failed to comply with the specification of the Laptop (*display, processor and peripheral*), and found to be non-responsive;

**WHEREAS**, on **11 June 2024**, the PBAC issued a Notice of Disqualification to Tekzone Computer Sales and Services, Inc. for non-compliance with the specification of the laptop (*a copy is hereto attached as Annex "C"*);

**WHEREAS**, on **13 June 2024**, the PBAC received a letter of Request (Motion) for Reconsideration from Tekzone Computer Sales and Services, Inc. (*a copy is hereto attached as Annex "D"*);

**WHEREAS**, upon careful deliberation conducted by the PBAC, the said request for reconsideration was denied when the BAC unanimously voted to sustain its prior decision to disqualify Tekzone Computer
