



**Bids and Awards Committee (BAC) Resolution Declaring  
1<sup>ST</sup> Failure of Bidding and Recommending Approval**

**Resolution No. 2019-051**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **18 July to 25 July 2019**, the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2018-12-1925/ IB No. 2019-005**, to wit:

**WHEREAS**, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, two (2) prospective bidders namely: 1) JHAK Construction, and 2) FFJJ Construction expressed their intention to participate. However, on 09 August 2019 only JHAK Construction attended the Pre-Bid Conference conducted by the PAGASA-BAC.

**WHEREAS**, all noted deviations and/or amendments attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB) with reference Addendum No. 2019-003\_1;2019-004\_01;2019-005\_01INF** dated **29 July 2019**, herein made part of this Resolution as Annex "A";

**WHEREAS**, on **22 August 2019** the schedule for **Submission and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only FFJJ Construction participated. The representative from FFJJ Construction expressed to the BAC members that their bidding documents were still in transit. Unfortunately, FFJJ Construction's bidding documents did not reach on time as schedule, hence, PAGASA-BAC members did not accept the submission thereof;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- to **DECLARE**, a **Failure of Bidding** for the above-entitled Project;
- to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof accordingly; and
- to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
