**Resolution Declaring 1<sup>ST</sup> Failure of Bidding;  
and Recommending Approval**

**Resolution No. 2019-074**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **27 September to 04 October 2019**, the procurement of the following the civil works with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2019-09-0725/ IB No. 2019-013INF**, to wit:

**WHEREAS**, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, in response to the said invitation, three (3) prospective bidder/s namely; 1) **R.A Mendiola Construction & Developer**; 2) **Rock 101 Construction and Supply**; and, 3) **T.M. Abad Construction** expressed their intention to participate in the bidding of the aforesaid Project, However, only R.A Mendiola Construction & Developer attended the Pre-Bid Conference conducted by the PAGASA-BAC on **07 October 2019**;

**WHEREAS**, on **21 October 2019**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), the **two (2) participating bidders** namely: 1) **Rock 101 Construction and Supply** and 2) **T.M. Abad Construction**, timely submitted their bid tenders for the projects; however, none of them passed the preliminary evaluation of bids due to failure to comply with the simple instructions to bidders;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a) to **DECLARE**, a **Failure of Bidding** for the above-entitled Project;
- b) to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof for re-bidding purposes; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
