WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **26 November to 03 December 2020**, the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2020-11-0534/ I.B. No. 2020-021**, to wit:
