**Resolution Declaring as SCR
 Recommending Award of Contract and Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 5 days from **27 April to 04 May 2022**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2022-03-0263 / I.B. No. 2022-014**, to wit:

WHEREAS, any and all noted deviations/amendments appurtenant to the Project has been issued through a **Supplemental Bid/Bulletin (SBB)**, with reference to **Addendum No. 2022-014-01** dated 04 May 2022 and **Addendum No. 2022-014-02** dated 19 May 2022 and herein made part of this Resolution as **Annex "A" and Annex "B"**;

WHEREAS, on **30 May 2022**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **the lone bidder** timely submitted its tender documents for the project and passed the preliminary examination of bids;
