Declaring Single Calculated and Responsive Bid (SCRB); and,
Recommending Award of Contract and Approval

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **16 to 23 June 2025**, the procurement of the following goods/items projects described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2024-11-0749 EPA || I.B. No. 2025-25** to wit:

WHEREAS, in response to the above advertisement, **eight (8)** prospective bidders namely: 1) **A.G. Datacom Philippines Incorporated**; 2) **Infocentric Solutions Inc.**; 3) **UBX Philippines Corporation**; 4) **One Commerce International Corporation**; 5) **REMAX International, Inc.**; 6) **Tekzone Computer Sales and Services**; 7) **Accent Micro Technologies Inc.**, and 8) **Banbros Commercial, Inc.** expressed their intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **24 June 2025**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, have been duly issued through a Supplemental Bid Bulletin (SBB), with reference to **Addendum No. 2025-25-01** dated 01 July 2025; **Addendum No. 2025-25-02** dated 07 July 2025, and **Addendum No. 2025-25-03** dated 22 July 2025, are herein made part of this Resolution as Annex "A"; Annex "B" and Annex "C" respectively;

WHEREAS, on **05 August 2025**, the re-scheduled **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Advance Solutions Inc.** timely submitted its bid tender documents for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the lone bidder financial proposal has been accepted for not exceeding the ABC. Its financial proposal, as "**Read**", is as follows:


