WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the Engineering and Technical Services Division (ETSD), intends to apply the amount of One Million Nine Hundred Twenty Thousand Pesos (Php1,920,000.00) only, covering the period of 12 months, under the reference, PR No. 2022-12-0969 EPA, for the renewal of subscription for Web Hosting Services for CY 2023, and more specifically described hereunder, as follows:

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **ADOPT**, the recommendation of the end-user to renew the Contract of Service Agreement to **SMS GLOBAL TECHNOLOGIES, INC.** for "Web Hosting Services", in the amount of **ONE MILLION NINE HUNDRED TWENTY THOUSAND PESOS ONLY (Php1,920,000.00)**;
- b) to **RECOMMEND, further**, the award of contract to **SMS GLOBAL TECHNOLOGIES, INC.** for the implementation of the above-entitled Project; and
- c) to **RECOMMEND**, finally the **APPROVAL**, of the foregoing findings and recommendations.
