**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **05-12 September 2019**, the procurement of the following the goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2019-08-0617/ IB No. 2019-034**, to wit:

Instead, PLDT submitted letter of withdrawal due to unavailability of Authorized Head signatory during the preparation of the bid document in connection to the aforesaid Project;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE**, a **Failure of Bidding** for the above-entitled Project;
- b) to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project, pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof for re-bidding purposes; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
