



**BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Approval**

**Resolution No. 2019-037**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **09 to 16 May 2019**, the **Re-Bid of the procurement** of the following goods/items described hereunder, with its corresponding Approved Budget for Contract (ABC), under the reference, **P.R. No. 2018-09-0684 and IB No. 2019-022**, to wit:

**WHEREAS**, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, in response to the said advertisement, four(4) prospective bidder/s namely: 1) **Tradewell Construction & Electrical Supply**; 2) **JT Max Power Equipment**; 3) **State Alliance** and 4) **Licht Industrial Corporation**, expressed its intention to participate in the bidding of the aforesaid Projects, purchased the requisite bidding documents, However, only the three(3) bidders namely: 1) Tradewell Construction & Electrical Supply; 2) JT Max Power Equipment and 3) State Alliance attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **17 May 2019**;

**WHEREAS**, all noted deviations and/or amendments attendant to the Project as discussed and agreed upon in the above mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB) with reference Addendum No. 2019-021-01 & 2019-022-02 dated 22 May 2019 and 2019-021-02 & 2019-022-02 dated 28 May 2019** herein made part of this Resolution as Annex "A";

**WHEREAS**, on **04 June 2019**, the **schedule for submission and opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **Licht Industrial Corporation** and **Tradewell Construction and Electrical Supply** timely submitted its bid tender and passed the preliminary examination of bids;

**WHEREAS**, in the subsequent opening of Envelope No. II (Financial Component), the Licht Industrial Corporation financial proposals have been accepted by the PAGASA-BAC having complied with the financial requirements of the project. While Envelope No. II (Financial Component) of Tradewell Construction and Electrical Supply was not opened because of the absence of countersignature in their NFCC (TAB E), Joint Venture Agreement (Tab F) and Bid Securing Declaration (Tab G) of the Eligibility and Technical Requirements and they opted to make a request for reconsideration. Their respective financial proposals, as **"READ"**, is summarized as follows:

**WHEREAS**, the report on the detailed evaluation of bids conducted by the TWG resulted in the following:

**WHEREAS**, upon careful examination, validation and verification of the tender offer, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that the Licht Industrial Corporation declared as disqualified bidder due to non compliance in some specification set forth by the End-User specifically in Output Rating and Piston Displacement. Hence, the BAC Committee declared a failure of bidding for the implementation of the instant Project.

**NOW, THEREFORE**, We, the Members of the PAGASA Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. to **DECLARE**, the **2<sup>nd</sup> Failure of Bidding** for the above-entitled Project;
- b. to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to **Section 35** of the IRR of R.A. 9184;
- c. to **RECOMMEND**, further that resort to the alternative method of procurement, through **Negotiated Procurement** pursuant to Section 53 (1) in relation with Section 35 of the IRR of RA 9184; and
- d. to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
