CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of _____, 20____ between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central, Quezon City, Metro Manila (hereinafter called the "Entity") and **DOMESTIC TRADING CORPORATION** of ACERO Building 891 E. Delos Santos Avenue.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of One Thousand Two Hundred (1,200) Pcs. Radiosonde Vaisala RS41-SG with Free Met Balloons (Reference: PR No. 2021-09-002EPA/ IB No. 2021-045) of TWENTY MILLION FOUR HUNDRED THOUSAND PESOS (Php20,400,000.00) ONLY** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum **TWENTY MILLION FOUR HUNDRED THOUSAND PESOS (Php20,400,000.00) ONLY** or such other sums as may be ascertained, **DOMESTIC TRADING CORPORATION**, agrees to **Supply and Deliver One Thousand Two Hundred (1,200) Pcs. Radiosonde Vaisala RS41-SG with Free Met Balloons** (Reference: PR No. 2021-09-002 EPA / ITB No. 2021-045) in accordance with his/her/its Bid.
4. The **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **20-27 October 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-09-0002EPA and ITB 2021-045**, to wit:

WHEREAS, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, only **Domestic Trading Corporation** expressed their intention to participate in the bidding of the aforesaid Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **28 October 2021**;

WHEREAS, on **09 November 2021**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Domestic Trading Corporation** timely submitted their bid tenders for the project and passed the preliminary examination of bids.

WHEREAS, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:
