**Resolution Declaring 1st Failure of Bidding and
Recommending Approval**

Resolution No. 2021-037

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **25 August to 01 September 2021**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2021-05-0317/ IB No. 2021-033**, to wit:

WHEREAS, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to said invitation, only **GENTEC DISTRIBUTION CORPORATION** expressed their intention to participate in the bidding of the aforesaid Project, purchased the requisite bidding documents and attended the Pre-Bid Conference conducted by the PAGASA-BAC on **02 September 2021**;

WHEREAS, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB)** with reference to **Addendum No. 2021-033-01** dated **06 September 2021** herein made part of this Resolution as Annex "A";

WHEREAS, on **14 September 2021**, the **schedule for submission and opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **Joint Venture of Gentec Distribution Corporation and Kister AG** timely submitted its bid tender for the Project but did not passed in the preliminary examination of bids and they opted to make a request for reconsideration.

WHEREAS, upon careful examination, validation and verification of **Joint Venture of Gentec Distribution Corporation and Kister AG** tender documents the PAGASA-BAC determined that, **Joint Venture of Gentec Distribution Corporation and Kister AG** declared as "Disqualified" due to failure to comply with the simple instructions to bidders more specifically,

failure to submit the supporting documents in their Single Largest Completed Contract (SLCC), namely; Copy of Certificate of Acceptance or Official Receipt / Collection Receipt.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED:**

- a) to **DECLARE**, a **Failure of Bidding** for the above-entitled Project;
- b) to **RECOMMEND** the mandatory review and evaluation of terms, conditions and specifications of the project pursuant to Section 35 of the IRR of RA 9184; and the immediate **re-posting** thereof accordingly; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
