Resolution Declaring 1st Failure of Bidding and Recommending Approval

Resolution No. 2021-042

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **30 September to 07 October 2021**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, **P.R. No. 2021-08-0567/ IB No. 2021-041**, to wit:

WHEREAS, the provision of R.A. 9184 and its revised Implementing Rules and regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to said invitation, only two (2) prospective bidder/s namely; 1) **A4V Technical & Industrial Corporation** and 2) **Licht Industrial Corporation** expressed their intention to participate in the bidding of the aforesaid Project, purchased the requisite bidding documents and attended the Pre-Bid Conference conducted by the PAGASA-BAC on **08 October 2021**;

WHEREAS, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB)** with reference to **Addendum No. 2021-041-01** dated **13 October 2021** herein made part of this Resolution as Annex "A";

WHEREAS, on **20 October 2021**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), two (2) bidder/s prospective bidders mentioned above timely submitted its bid tender for the Project; However, the Envelope II (Financial Component) of both bidder was not open because none of them passed the preliminary examination of bids due to failure to comply with the simple instructions to the bidders;
