Resolution No. 2023-029

**Declaring Lowest Calculated and Responsive Bid (LCRB);
 Recommending Award of Contract; and Recommending Approval**

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the MGEPS and PAGASA Bulletin board continuously for 7 days from **30 May to 06 June 2023**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under the reference, P.R. No. 2023-04-0292 / I.B. No. 2023-005 to wit:

WHEREAS, in response to the above advertisement, **five (5) prospective bidders** namely: 1) **One Commerce (Int'l) Corporation**; 2) **EGM System Global Technologies Inc.**; 3) **Automation Specialist and Power Exponent (ASPEX), Inc.**; 4) **LSI Leading Technologies, Inc.**, and 5) **Superserve Corporation**, expressed its intention to participate in the bidding of the aforesaid Project, on the scheduled **Pre-bid conference** conducted by the PBAC on **07 June 2023**;

WHEREAS, any and all noted amendments and deviations discussed during the above-mentioned Pre-bid conference, has been duly issued through a **Supplemental Bid Bulletin (SBB)**, with reference to **Addendum No. 2023-005-01** dated 13 June 2023 and herein made part of this Resolution as **Annex "A"**;

WHEREAS, on **19 June 2023**, the schedule for **Submission, Receipt and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), **two (2) prospective bidders** namely; 1) **Automation Specialists and Power Exponents (ASPEX) Inc.**, and 2) **Tekzone Computer Sales and Services, Inc.** timely submitted their bid tenders for the project and passed the preliminary examination of bids;

WHEREAS, in the subsequent opening of Envelope No. II, the bidder's financial proposal has been accepted by the PAGASA-BAC having complied with the financial requirements of the Projects; Their respective financial proposals, **"as Read"**, is summarized as follows:

WHEREAS, upon careful examination, validation and verification of the two (2) bidder's tender documents, including the evaluation report submitted by the TWG, the PAGASA-BAC determined that, **Tekzone Computer Sales and Services, Inc.** has complied accordingly on all the criteria for post-qualification and was responsive on all requirements and conditions specified in the Bidding Documents, Hence, it was moved and duly seconded that the **Tekzone Computer Sales and Services, Inc.** be declared as the **Lowest Calculated and Responsive Bidder (LCRB)** for the Project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) to **DECLARE, Tekzone Computer Sales and Services, Inc.**, as the Bidder with the Lowest Calculated and Responsive Bid (LCRB) for the Project entitled, *"Supply, Delivery, Installation, Testing and Commissioning of Two sets (2 units/set) of 10kVA Single Phase Uninterruptible Power Supply"* in the total amount of **One Million Nine Hundred Twenty Thousand Pesos (Php1,920,000.00)** only;
- b) to **RECOMMEND**, the award of the contract to **Tekzone Computer Sales and Services, Inc.** for the implementation of the above-entitled Project; and
- c) to **RECOMMEND**, finally, the **APPROVAL** of the foregoing findings and recommendations.
