- 6. Notice of Award shall be issued within 7 working days after the opening of bids.
- 7. Full Payment shall be made within 5 days after the receipt of the Notice of Award. No bid bond is required on this alternative mode of disposal for junk/scrap.
- 8. Authority to pull-out shall be issued within 5 days after the full payment.
- Authorization letter shall be presented for authorized representative prior to pullingout for proper identification.
- 10. The actual release/withdrawal of awarded items shall only be made during regular office hours and shall be witnessed by the Property Officer, representatives of the PAGASA Disposal Committee, Commission on Audit (COA) and the Chief Security Officer who shall affix their signatures on the "Release Order" (RO) or the GATE PASS.


