# Resolution Declaring Single Calculated Responsive Bid (SCRB) and Recommending Award and Approval

## Resolution No. 2021-051

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **30 September - 07 October 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-08-0542 and ITB 2021-042**, to wit:

**WHEREAS,** the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, three (3) prospective bidder/s namely: 1) ASPEX, Inc.; 2) A4V Technical and Industrial Corporation; and, 3) Superserve Corporation, expressed their intention to participate in the bidding of the aforesaid Project, and attended the Pre-Bid Conference conducted by the PAGASA-BAC on 08 October 2021;

WHEREAS, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a Supplemental Bid/Bulleting (SBB) with reference to Addendum No. 2021-042-01 and 2021-042-02 dated 13 October 2021 herein made part of this Resolution as Annex "A";

WHEREAS, on 20 October, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only Superserve Corporation timely submitted their bid tenders for the project and passed the preliminary examination of bids.

**WHEREAS**, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:

Hence, it was moved and duly seconded that Superserve Corporation be declared as the bidder with the Single Calculated and Responsive Bid (SCRB) for the implementation of the instant Project.
