



WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **30 September - 07 October 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-07-0476 and ITB 2021-040**, to wit:

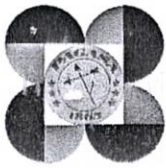

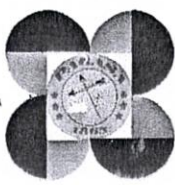

CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 13, 2022 day of _____, 20____ between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central, Quezon City, Metro Manila (hereinafter called the "Entity") and **AMERICAN TECHNOLOGIES, INC. of # 5 ATI Bldg. Ideal cor. Mccolough St., Brgy. Addition Hills.**


