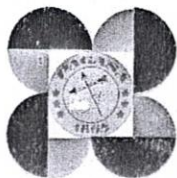

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **25 August to 01 September 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-07-0469 and ITB 2021-032**, to wit:

WHEREAS, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, only (1) bidder/s participated namely; 1) **Enhanced Electronics and Communication Services Incorporated** expressed its intention to participate in the bidding of the aforesaid Project, purchased the requisite bidding documents and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **02 September 2021**;

WHEREAS, on **14 September 2021**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Enhanced Electronics and Communication Services Incorporated** timely submitted their bid tenders for the project and passed the preliminary examination of bids.

CONTRACT AGREEMENT

THIS AGREEMENT, made this **DEC 13 2021** day of _____, 20____ between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central, Quezon City, Metro Manila (hereinafter called the "Entity") and **ENHANCED ELECTRONICS & COMMUNICATION SERVICES** of Unit 406, 4th Floor AIC Burgundy Empire Tower, ADB Avenue corner Garnet Road, Pasig City

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Radiosonde Transmitter Graw Met DFM-06 with Free Met. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **FOUR MILLION TWO HUNDRED FORTY FIVE THOUSAND EIGHT HUNDRED SEVENTY SIX and 60/100 PESOS (Php4,245,876.60) ONLY** or such other sums as may be ascertained, **ENHANCED ELECTRONICS & COMMUNICATION SERVICES** agrees to **Supply and Deliver of Radiosonde Transmitter Graw Met DFM-06 with Free Met. Balloons** in accordance with his/her/its Bid.




