



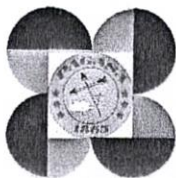

**Resolution Declaring Single Calculated Responsive Bid (SCRB)
and Recommending Award and Approval**

Resolution No. 2021-038

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **25 August to 01 September 2021** the procurement of the following civil works described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-08-540 and ITB 2021-035**, to wit:

WHEREAS, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, **three (3)** prospective bidder/s namely; 1) **Dynamic Power & Marine Industrial Hardware Inc.**; 2) **Licht Industrial Corporation**; and 3) **A4V Technical & Industrial Corporation** expressed its intention to participate in the bidding of the aforesaid Project, purchased the requisite bidding documents, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **02 September 2021**;

WHEREAS, on **14 September 2021**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), three (3) prospective bidder/s namely; 1) **A4V Technical & Industrial Corporation**; 2) **Licht Industrial Corporation**; and 3) **Dynamic Power & Marine Industrial Hardware Inc.** timely submitted their bid tenders for the project. However, only **Licht Industrial Corporation** passed the preliminary examination of bids while the other bidders did not pass due to non-compliance of the simple instructions to bidders.

WHEREAS, in the subsequent opening of Envelope No. II (Financial Component), the **Licht Industrial Corporation** financial proposals have been accepted by the PAGASA-BAC having complied with the financial requirements of the project, while Envelope No. II (Financial Component) of the two bidders who did not passed in preliminary examination of bids was not opened and they opted to make a request for reconsideration. Their respective financial proposals, as "**READ**", is summarized as follows:



THIS AGREEMENT, made this DEC 14 day of 2021, 20 between
**PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES
ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central,
Quezon City, Metro Manila (hereinafter called the "Entity") and **LICHT INDUSTRIAL
CORPORATION** of #45 Don Pablo Subdivision, Barangay Rincon, Valenzuela City

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly
**Supply, Delivery, Installation, Testing and Commissioning of One (1) Unit 200 KVA
Three-Phase Generator Set for the Wind Tunnel of Davao PAGASA Station
Complex. (Reference: PR No. 2021-08-0540 / IB No. 2021-035)** and has accepted a Bid

construed as integral part of this Agreement, viz.:

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and
Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's
bidding envelopes, as annexes, and all other documents submitted (e.g.,
Bidder's response to request for clarifications on the bid), including corrections
to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the
Procuring Entity concerned in the PBDs. Winning bidder agrees that
additional contract documents or information prescribed by the GPPB
that are subsequently required for submission after the contract
execution, such as the Notice to Proceed, Variation Orders, and Warranty


