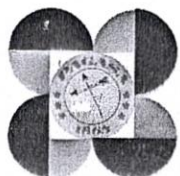

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **25 August to 01 September 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-08-0543 and ITB 2021-034**, to wit:

WHEREAS, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, three (3) bidder/s participated namely; 1) **Tekzone Computer Sales and Services, Inc.**; 2) **Pronet Systems Integrated Network Solution, Inc.**, and) **First Datacorp** expressed its intention to participate in the bidding of the aforesaid Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **02 September 2021**;

CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 14 2021 day of December, 2021 between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central, Quezon City, Metro Manila (hereinafter called the "Entity") and **TEKZONE COMPUTER SALES AND SERVICES** of 32 Pilar Street corner Araullo Street, Brgy. Addition Hills, San Juan City.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery, Training and Commissioning of Data Center Distribution Switch Access and Firewall (Reference: PR No. 2021-08-0543 / IB No.2021-038)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN MILLION NINE HUNDRED THOUSAND PESOS (Php7,900,000.00) ONLY** (hereinafter called "the Contract Price").

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **SEVEN MILLION NINE HUNDRED THOUSAND PESOS (Php7,900,000.00) ONLY** or such other sums as may be ascertained, **TEKZONE COMPUTER SALES AND SERVICES** agrees to **Supply, Deliver, Supply, Deliver, Train and Commission of Data Center Distribution Switch Access and Firewall** in accordance with his/her/its Bid.




