**Resolution Declaring as Single Calculated and Responsive Bid,  
Recommending Acceptance of the Lowest Price Quotation;  
and Recommending Approval**

**Resolution No. 2020-034**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) through the Bids and Awards Committee (PAGASA-BAC), has posted the **Notice to Bidders (NTB)** on 05 November 2020 at the PAGASA website, the G-EPS and PAGASA Bulletin Board, notifying all interested bidders of the Agency's **resort to Alternative Method of Procurement through Negotiated Procurement** under **Rule XVI, Section 53.1** of the Revised IRR of R.A. 9184, following two failures of Public Bidding the procurement of the following good/item with their corresponding Approved Budget for the Contract (ABC) under **PR No. 2020-01-0079/2020-003NP**, to wit:

**WHEREAS**, the following bidders/suppliers who are duly accredited and listed under PAGASA's list of legitimate suppliers have been invited to submit their respective lowest price quotations:

- 1) Integrated Computer System, Inc.
- 2) Tekzone Computer Sales & Services Inc.
- 3) Accent Micro Technologies Inc.
- 4) Any Network System, Inc.
- 5) Columbia Tech Corp.

**WHEREAS**, in response to the said invitation, only **Integrated Computer System, Inc.** expressed its intention to participate in bidding of the aforesaid Project, but did not attend the **Pre-Bid Conference** conducted by the Bids and Awards Committee on **20 November 2020**;

**WHEREAS**, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB) Addendum No. 2020-003NP-01 and 2020-003NP-02** dated **16 November 2020 and 27 November 2020** respectively, herein made part of this Resolution as Annex "A";

**WHEREAS**, on **02 December 2020**, the schedule for **Submission and Opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Integrated Computer System, Inc.** timely submitted its bid tender and passed the preliminary examination of bids;

**WHEREAS**, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:
