

Resolution Declaring Single Calculated Responsive Bid (SCRB) and Recommending Award and Approval

Resolution No. 2021-001

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **30 October to 06 November 2020**, the procurement of goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR#2020-10-005EPA and IB 2021-002**, to wit:

WHEREAS, the provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

WHEREAS, in response to the said invitation, only the **Enhanced Electronics and Communication Services Inc.**, expressed their intentions to participate in the bidding of the aforesaid Project and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **09 November 2020**;

WHEREAS, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB) Addendum No. 2021-002-01** dated **18 November 2020**, herein made part of this Resolution as Annex "A";

WHEREAS, on **23 November 2020**, the **schedule for submission and opening** of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **Enhanced Electronics and Communication Services Inc.** timely submitted its bid tender and passed the preliminary examination of bids;

WHEREAS, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:

CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of _____ 20____ between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)**, of the Philippines, hereinafter called as the “**PAGASA**” of the one part and **ENHANCED ELECTRONICS AND COMMUNICATIONS SERVICES, INC. of 406 AIC Burgundy Empire Tower, ADB Avenue corner Garnet Road Pasig City** hereinafter called as the “**SUPPLIER**” of the other part:

WHEREAS the **PAGASA** invited Bids for certain Goods and Services, viz., **Supply and Delivery of Five Hundred (500) pcs. Radiosonde Transmitter – Graw Met. DFM-06 with Free Met Balloons (PR No. 2020-10-005EPA / IB No. 2021-002)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **EIGHT MILLION FOUR HUNDRED NINETY ONE THOUSAND SEVEN HUNDRED FIFTY THREE and 20/100 PESOS (Php8,491,753.20) ONLY** (hereinafter called “the Contract Price”).
