

WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA) through the Engineering and Technical Services Division (ETSD) requested herein the item indicated hereunder with their Approved Budget for the Contract (ABC) under **P.R. No. 2020-10-0531** to wit;

WHEREAS, by virtue of its mandate and functions provided for under the procurement law including its revised implementing rules and regulations (IRR), the PAGASA-BAC carefully examined and scrutinized the purpose, nature and scope of services of the instant Project upon receipt of the end-user unit's proposal thereto;

WHEREAS, after a careful examination, evaluation and scrutiny of the above Project proposal, the PAGASA-BAC determined that the Project requirements and the scope of services required therein, including the determination of the Approved Budget for the Contract are in order;

WHEREAS, for and in consideration the necessity for the subscription of Internet Access Service and Leased-line Services using IP/VPN is to provide connectivity and internet access around the vicinity in Bohol Radar Station. In addition, the fiber optic services and connection node/box is already installed at the PAGASA service post

WHEREAS, the PAGASA-BAC determined based on records that the Agency had an existing contract of similar nature with **PLDT** covering the agency's various telecommunication services. Furthermore, **PLDT** consistently provide excellent services to all telecommunication subscription utilities to PAGASA and provide internet connectivity to several PAGASA Stations; Thus, PAGASA-BAC finds merit and legal basis to recommend the resort to alternative method of procurement through Direct Contracting under Section 50 of the revised IRR (R.A. 9184).


