



WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **06 to 13 November 2020**, the procurement of goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR#2020-10-007EPA** and **IB 2021-004**, to wit:

WHEREAS, the report on the detailed evaluation of bids conducted by the TWG resulted in the following:






