WHEREAS, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **26 November to 03 December 2020** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2020-11-019EPA and ITB 2021-011**, to wit:

CONTRACT AGREEMENT

De Rivera St., San Nicolas, Manila** hereinafter called as the "**SUPPLIER**" of the other part:

WHEREAS the **PAGASA** invited Bids for certain Goods and Services, viz., **Supply, Delivery, Installation, Testing and Commissioning of the Data processing System Conforming to the New Aviation Protocol (PR No. 2020-10-019EPA / IB No. 2021-011)** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **TWENTY TWO MILLION THREE HUNDRED ELEVEN THOUSAND PESOS (Php22,311,000.00) ONLY** (hereinafter called "the Contract Price").
