

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **23 to 30 June 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-06-0383 and ITB 2021-027**, to wit:

**WHEREAS**, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, in response to the said invitation, four (4) prospective bidders namely: 1) **Global Trends**; 2) **EGM Systems Global Technologies Inc.**; 3) **LSI Leading Technologies, Inc.**, and 4) **Automation Specialists and Power Exponents, Inc.** expressed its intention to participate in the bidding of the aforesaid Project, purchased the requisite bidding documents and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **01 July 2021**;

**WHEREAS**, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB) Addendum No. 2021-027-01** dated **07 July 2021**, herein made part of this Resolution as Annex "A";

**WHEREAS**, on **13 July 2021**, the schedule for submission and opening of Envelope I (Eligibility and Technical Components) and Envelope II (Financial Component), only **EGM Systems Global Technologies Inc. Joint Venture with Powercraft Solutions and Data Infrastructure Inc.** timely submitted their bid tenders for the project and passed the preliminary examination of bids.

**WHEREAS**, the lone bidder's financial proposal has been accepted for not exceeding the ABC. Its bid tender, "as Read", is as follows:

## CONTRACT AGREEMENT

THIS AGREEMENT, made this 12 day of OCT, 2021 between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central, Quezon City, Metro Manila (hereinafter called the "Entity") and **EGM SYSTEMS GLOBAL TECHNOLOGIES, INC Joint Venture with POWERCRAFT SOLUTIONS and DATA INFRASTRUCTURE INC.. of Unit 309, Armal Plaza Bldg. C. Raymundo Avenue, Maybunga Pasig City.**

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery, Installation, Testing, Training and Commissioning of Two (2) Units of 10KVA Uninterruptable Power Supply (UPS), One (1) Unit Internal Battery and Three (3) Units Battery Packs** (Reference: PR No. 2021-06-0383 / IB No. 2021-027) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **NINE HUNDRED NINETY NINE THOUSAND NINE HUNDRED PESOS (Php999,900.00) ONLY** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract**
