**Resolution No. 2021-024**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the mPhilGEPS and PAGASA Bulletin board continuously for 7 days from **24 to 31 May 2021** the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for the Contract (ABC), under **PR No. 2021-03-0224 and ITB 2021-022**, to wit:

**WHEREAS**, the provision of R.A. 9184 and its Revised Implementing Rules and Regulations (IRR), other pertinent guidelines and procedures relative to government procurement system are hereby observed and strictly implemented for the whole duration of this bidding activity;

**WHEREAS**, in response to the said invitation, only **State Alliance Enterprises, Inc.** expressed its intention to participate in the bidding of the aforesaid Project, and attended the **Pre-Bid Conference** conducted by the PAGASA-BAC on **01 June 2021**;

**WHEREAS**, all noted deviations and/or amendments including the BAC's answer and the clarificatory letter/s submitted by the prospective bidder attendant to the Project as discussed and agreed upon in the above-mentioned meeting was issued through a **Supplemental Bid/Bulletin (SBB)** with reference to **Addendum No. 2021-022-01** dated **01 June 2021**, herein made part of this Resolution as Annex "A";

## CONTRACT AGREEMENT

THIS AGREEMENT, made this 20 day of AUG 20 2021, 2021 between **PHILIPPINE ATMOSPHERIC GEOPHYSICAL AND ASTRONOMICAL SERVICES ADMINISTRATION (PAGASA)** of Science Garden Compound, BIR Road, Barangay Central, Quezon City, Metro Manila (hereinafter called the "Entity") and **STATE ALLIANCE ENTERPRISE INC. of 283 G. De Rivera St. San Nicolas, Manila**

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Repair and Maintenance of Hydrogen Generator at PAGASA Puerto Princesa Station** (Reference: PR No. 2021-03-0224 / IB No. 2021-022) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FOUR MILLION SIX HUNDRED NINETYSIX THOUSAND FIVE HUNDRED PESOS (Php4,696,500.00) ONLY** (hereinafter called "the Contract Price").

    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **FOUR MILLION SIX HUNDRED NINETYSIX THOUSAND FIVE HUNDRED PESOS (Php4,696,500.00) ONLY** or such other sums as may be ascertained, **STATE ALLIANCE ENTERPRISE INC.** agrees to **Repair and Maintenance of Hydrogen Generator at PAGASA Puerto Princesa Station** in accordance with his/her/its Bid.

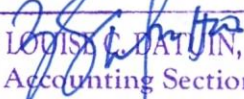
