1.	Will there be any connectivity required in the Project?	Yes, this is to integrate the following in one single VPN link: Internet 50mb VSAT2mb MPLS/IPVPN 10mb
2.	May we request to be allowed to submit aggregate contracts; 1 at least being 25% of the ABC to meet the 50% SLCC requirement of 36M?	Please refer to Section II Instruction to Bidders 5.3: For the procurement of Non-expendable Supplies and Services: The Bidder must have completed <u>a single</u> <u>contract</u> that is similar to this Project, equivalent to <u>at least fifty percent (50%)</u> of the ABC.

8.	Clarification for the 24 port switches: Per required switching capacity of 176 Gbps, only 48 port switches can satisfy the said switching capacity.	We required the 176 Gbps Switching Capacity and 24 port switches.
