Part of the eligibility documents is a certification that the contractor has presented their proof of concept of the project and has met the criterion set by the technical specifications.</p> <p>To allow other bidders to join the bid and comply with this requirement, we would like to recommend that the POC be included as part of the testing phase before the site is accepted during implementation or allow the bidders to conduct a POC once the bidder is declared as the winning bidder.</p>	<p><i>The requirement for the contractor to present a Proof of Concept (POC) certification within the PAGASA framework or from any other recognized agency/entity remains a mandatory pre-qualification requirement. The intent is to ensure that only bidders with a proven and validated capability in the field are allowed to participate.</i></p>
