Supply, Delivery, Installation, Testing, Training and Commissioning of Radar Systems within the last 10 years.</b></p> <p><b>OR</b></p> <p><b>a. Supply, Delivery, Installation, Testing, Commissioning and Maintenance of Weather Radar Systems within the last 3 years.</b></p>	<p><b><u>CLARIFICATION:</u></b></p> <p>In accordance with Section 52.4.1.3 of the Implementing Rules and Regulations (IRR) of R.A.12009 for the procurement of goods, a bidder is required to submit a Single Largest Completed Contract (SLCC) similar to the project, with a value of at least fifty percent (50%) of the Approved Budget for the Contract (ABC).</p> <ol style="list-style-type: none"> <li>1. The bidder should have completed at least one (1) similar contract amounting to at least 25% of the ABC; and</li> <li>2. The bidder should have completed other contracts, whether similar or not, with an aggregate amount of at least 25% of the ABC.</li> </ol>

This shall form an integral part of the Bid Documents.
