2. May we request if we can omit "2.7mm" and "carbon fiber" under your Display requirement? This specification might only limit your requirement to a certain brand or model. Display size, type, resolution and touch function would be enough and applicable across other brands of laptop computers.	No. Please refer to TOR's specifications.
3. Would you allow or consider an equivalent to "Express Charge"? Provided that the laptop we offer has a function or support for fast charging of laptop battery?	No. Please refer to TOR's specifications.
May we know your required subscription period for the security/anti-virus software?	One (1) year – existing anti-virus
LAPTOP (15.6 inches)	
Mobile Workstations today are slimmer by design. Also, to increase the performance, these devices run on SSD (no HDD anymore). Would you consider increasing the SSD storage capacity to 1TB and remove the HDD requirement?	We prefer the specifications indicated in the TOR.
2. In addition, may we also request if we can omit SSD Storage "Class 35" type? This is for the reason that manufacturers do not indicate Class Type of SSD in their datasheet or brochure. What they normally present is the storage capacity, type and form factor.	No. Please refer to TOR's specifications.

3. May we request if you will allow or consider to omit the graphics card specific "NVidia Quadro P620" and retain 4GB GDDR5 as a minimum requirement?	No. Please refer to TOR's specifications.	
4. May we know what would you mean by "Dual pointing" backlit Keyboard? Normally a laptop has a single touchpad and used as a pointing device.	Dual pointing set up means the system will have two sets of mouse – one above and one below the touchpad.	
5. Would you allow or consider an equivalent to "Express Charge"? Provided that the laptop we offer has a function or support for fast charging of laptop battery?	No. Please refer to TOR's specifications.	
6. Would you consider or allow laptop weight adjusted to a maximum of 2.1Kg?
