<p>TAB G: Bid Security</p> <p>We have noted that there are three listed conditions under Tab G – Bid Security. May we respectfully seek clarification on whether all three requirements must be complied with and submitted?</p>	<p>The three conditions or forms listed under Tab G – Bid Security are alternative options. As such, bidders are required to submit only one of the acceptable forms of bid security, as stated in the Bidding Documents. You may choose the form most appropriate to your organization, provided it meets the required amount and validity period in accordance with the provisions of RA 9184 and its Revised Implementing Rules and Regulations (IRR).</p>
<p>TAB H-2: Duly Filled-up Manufacturer's Authorization Form or Duly Authenticated Certification of Sole/Exclusive Distributorship issued by the manufacturer</p> <p>We have noted that there are two types of forms attached under Tab H-2. Upon review, the contents of both forms appear to be the same. May we respectfully seek clarification on whether it is necessary to submit both forms, or if submitting only one—in accordance with the applicable requirement—would suffice?</p>	<p>Please note that the two forms under Tab H-2 and Tab H-2.1 are different and serve specific purposes:</p> <ul style="list-style-type: none">• Tab H-2 Manufacturer's Authorization Form is for bidders who are authorized by the manufacturer to offer and supply the goods.• Tab H-2.1 Certification Under Oath is a sworn affidavit whereby the bidder assumes legal responsibility should any MAF be false or improperly obtained. <p>Please be advised that both the Manufacturer's Authorization Form (Tab H-2) and the Certification Under Oath (Tab H-2.1) must be submitted as part of the bid documents. Submission of these forms is necessary to ensure that the bidder is duly authorized by the manufacturer and to affirm the authenticity and legality of the Manufacturer's Authorization Form.</p> <p>Please refer to attached Annex H-2 and Annex H-2.1 sample forms</p>
