## SUPPLEMENTAL BID BULLETIN ADDENDUM NO. 2022-029-02

## Subject: <u>Supply, Delivery, Installation, Testing and Commissioning of the Amihan and Habagat</u> <u>Conference Room Audio Video System Upgrade and Room Rehabilitations</u>

This Bid Bulletin is being issued to all prospective bidders to clarify, amend and/or modify certain provisions in the Bidding Documents and to answer the written clarificatory questions submitted by prospective bidders, to wit:

## Query from ALL VISUAL & LIGHTS SYSTEMS

Question(s)		PAGASA BAC Answer(s)
1.	During the Pre-Bid Conference, upon the presentation of Section VI Technical Specification it specified that the bidders are require to submit a certification from the manufacturer/distributor. Can we provide a Reseller Certificate instead of Manufacturer Certificate?	Yes, bidders may be allowed to submit a Re-seller certificate/authorization, provided that proof of authority of the latter to distribute the specific item is also attached/submitted.
2.	Regarding Watermarked for the Bidding Forms document required by PAGASA. Is it applicable for all Documents or just for the Bidding Forms only?	All bidding forms issued and prescribed by the PAGASA-BAC contain watermark logo of the Agency. The same must appear on the prescribed bidding forms to be submitted by the bidders.
3.	6 IUS in the terms of reference – We would like to suggest lessening the quantity to 3-4 sets of IUS for a 12-seater table. As it will require more cables that will go to the equipment, rack or display and this will also require an HDMI switcher that is not in included on the BOQ to accommodate those quantities of HDMI.	The number of IUS is hereby reduced from six (6) sets to four (4) sets, however, compatible HDMI switcher must also be provided.
4.	We do suggest for the power provision, we will just tap in parallel on existing outlet, please confirm Section VI item 6&7 for Habagat room.	This matter shall be subjected to further discussion with the winning bidder during the kick-off meeting together with our Engineering and Technical Services personnel.
	Statement of bidder's Single Largest Completed Contract (SLCC) similar in nature to the Contract to be bid within the period of three (3) years. Can we request SLCC within the period of five (5) years.	Statement of bidder's Single Largest Completed Contract (SLCC) similar in nature to the Contract to be bid for the period of three (3) years to five (5) years.

This shall form an integral part of the Bid Documents.
