They should have a pool of engineers/technicians and submit the bio-data including certificates and diplomas as proof.</p> <p>3.2.2 To ensure the availability of parts the bidder must be an exclusive distributor of the brand of ACU to be delivered in the Philippines and as proof should submit a certificate of exclusive distributorship from the manufacturer.</p>	<p>Exclusive distributorship is applicable for direct contracting, otherwise manufacturer's authorization will do.</p>
